RESOLUTION

ON THE AMENDMENT OF RESOLUTION NO 512 OF 28 JUNE 2023 OF THE GOVERNMENT OF THE REPUBLIC OF LITHUANIA ON THE APPLICATION OF NATIONAL CONTROL MEASURES PURSUANT TO ARTICLE 9 OF REGULATION (EC) NO 2021/821 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL

The Government of the Republic of Lithuania *d e c i d e s*:

1. To amend Resolution No 512 of 28 June 2023 of the Government of the Republic of Lithuania on the Application of National Control Measures pursuant to Article 9 of Regulation (EC) No 2021/821 of the European Parliament and of the Council:

1.1. To amend the title to read as follows:

“ON THE AMENDMENT OF RESOLUTION NO 512 OF 28 JUNE 2023 OF THE GOVERNMENT OF THE REPUBLIC OF LITHUANIA ON THE APPLICATION OF NATIONAL CONTROL MEASURES PURSUANT TO ARTICLE 9 OF REGULATION (EC) NO 2021/82.”

1.2. To amend paragraph 4 to read as follows:

“4. To establish that this Resolution shall expire on 2 January 2025.”

1.3. To amend the National List of Controlled Dual-Use Items approved according to the above-mentioned Resolution:

1.3.1. To declare paragraph 4 invalid.

1.3.2. To add paragraphs 11¹-11³:

“11 ¹ .	8457	Machining centres, unit construction machines (single station) and multi-station transfer machines, for working metal
11 ² .	8458	Lathes (including turning centres) for removing metal
11 ³ .	8459	Machine tools (including way-type unit head machines) for drilling, boring, milling, threading or tapping by removing metal, other than lathes (including turning centres) of heading 8458”.

1.3.3. To amend paragraph 12 to read as follows:

“12.	8466	Parts and accessories suitable for use solely or principally with the machines of headings 8456 to 8465, including work or tool holders, self-opening dieheads, dividing heads and other special attachments for machine tools; tool holders for any type of tool for working in the hand”.

1.3.4. To add paragraphs 24¹ and 24²:

“24 ¹ .	8506 10	Manganese dioxide primary cells and primary batteries
24 ² .	8506 50	Lithium primary cells and primary batteries”.

1.3.5. To add paragraphs 27¹ and 27²:

“27 ¹ .	8523 49	Optical storage; other
27 ² .	8523 80	Semiconductor storage; other”.

1.3.6. To declare paragraph 32 invalid.

1.3.7. To add paragraph 45¹:

“45 ¹ .	8704	Motor vehicles intended for the carriage of goods”.

1.3.8. To declare paragraphs 50 and 51 invalid.

1.3.9. To add paragraph 53¹:

“53 ¹ .	9025 80	Barometers, not combined with other instruments, electronic and other, of heading 9025 80”.
