MEDIA ACCREDITATION

Media accreditation is mandatory for all media representatives wishing to cover the MED9 Summit. Accreditation grants access to designated media facilities and publicly accessible Summit activities, subject to security regulations and organizational requirements.

The media representatives should submit an **accreditation request** by completing the **official [Online Media Accreditation Form](#) until 2 October 2026**.

A duly completed and submitted accreditation form shall be considered a valid accreditation request. **Individual confirmations of receipt will not be issued. Unless contacted otherwise by the organizers, applicants whose forms have been properly completed and submitted within the prescribed deadline shall be considered accredited.**

The organizers reserve the right to request additional documentation where necessary, including a valid press card, passport copy, assignment letter, proof of employment or examples of recent published work.

ACCREDITATION BADGE PICK-UP

Media representatives are kindly requested to present a valid identification document when collecting their accreditation badge. Accreditation badges must be worn visibly at all times while inside the conference venue and in all media-designated areas.

VENUE, PRESS CENTRE AND PRESS ROOM

The MED9 Summit will be held at [Radisson Blu Resort & Spa](#), Put Trstenika 19, 21000, Split. The plenary session will take place in hotel (ground level).

The official Press Centre for accredited media representatives will be at hotel (ground level, room TBD). The room will serve as a dedicated workspace where journalists may follow the MED9 Summit, prepare reports, conduct editorial work and use the available media facilities.

A separate Press Room, located at hotel (ground level, room TBD), will be available for official media activities. It is designated for interviews, media statements, press briefings, television and radio recordings.
