Monday 12 May 2014

Foreign Affairs Council - overview of the agenda

The Council, chaired by EU High Representative Catherine Ashton, will discuss the **Ukraine** crisis and take stock of ongoing work, including on diplomatic efforts to promote de-escalation of the situation, EU support to security sector reform in Ukraine, the EU's policy regarding Crimea and restrictive measures.

The Council will also debate the state of play regarding the **Middle East peace process**, taking also into account the <u>statement</u> of EU High Representative Catherine Ashton of 27 April.

It will discuss the EU's **neighbourhood policy** for 2014, inter alia on the basis of a joint communication of the Commission and the High Representative (<u>8595/14</u>). This annual stocktaking of the implementation of EU neighbourhood policy reports on the Union's engagement with, and support of, its neighbours to the East and South.

The Council is expected to adopt conclusions on Ukraine and the Middle East Peace Process.

A Stabilisation and Association Council with **Albania** will take place in the margins of the Foreign Affairs Council on 12 May. On 13 May, the EU-**Algeria** Association Council will be held.

General Affairs Council - overview of the agenda

The Council meeting will be devoted to the **preparation of the European Council** on 26-27 June. For that purpose, ministers will examine the draft annotated agenda (<u>8280/14</u>). The European Council is expected to focus in particular on the area of freedom, security and justice; the European Semester; and climate and energy issues. The European Council may also address specific external relations issues in light of developments on the international scene.

Foreign Affairs Council - development cooperation issues

EU ministers for development cooperation, meeting within the Foreign Affairs Council, are expected to exchange views on the **post-2015 agenda for sustainable development and poverty eradication**.

The Council will be briefed by the Commission on the implementation of the **agenda for change**.

The Council will also debate a **rights-based approach to development cooperation**, encompassing all human rights, and adopt conclusions.

Over working lunch, ministers are set to discuss development cooperation with the **Central African Republic** and with **South Sudan**.

In addition, the Council is expected to adopt conclusions on the EU's comprehensive approach as well as on the annual report 2014 to the European Council on EU development aid targets.

Agriculture and Fisheries Council - overview of the agenda

The Council will have an exchange of views on a report from the Commission on the establishment of a European fund for minor uses in the field of plant protection products. Regulation 1107/2009 governs the placing of plant protection products (PPP) on the market and contains special provisions for the application and authorisation of so-called minor uses. These are uses of PPP that are economically not sustainable for the plant protection industry, but important for growers. The Commission report highlights the main causes for the minor uses problem and proposes the establishment of a coordination group.

In addition, ministers will be briefed on food loss and food waste, on the climate and energy framework 2030 and on the protection of animals during transport.

Tuesday 20 May 2014

Education, Youth, Culture and Sport Council - education and youth issues

At its education session, the Council is due to adopt conclusions notably on:

- **effective teacher education,** which address concrete issues such as how to attract and retain the best candidates, how to ensure the relevance of teacher education programmes and how to better exploit the potential of new technologies and resources;
- **multilingualism and the development of language competences,** inviting member states to improve measures aimed at promoting multilingualism and enhancing the quality and efficiency of language learning and teaching, as well as to develop appropriate methods for assessing language proficiency;

Ministers will also hold, in public deliberation, a debate on the subject **"Education crossing borders: new opportunities and challenges"**, on the basis of a Presidency discussion paper (9127/14).

In its <u>youth configuration</u>, the Council and the representatives of the governments of the member states are expected to adopt two resolutions on

- the **structured dialogue process** (a forum for joint reflection on the priorities, implementation and follow-up of European cooperation in the youth field), including social inclusion of young people (<u>9026/14</u>), which reviews achievements during the last cycle and establishes priorities for work in the next 18 month cycle.
- the **EU Work Plan for Youth**, a short and medium term plan with a limited number of key policy initiatives to address specific issues and political priorities of the moment in order to respond more efficiently to the consequences of the current crisis on youth.

The Council is also due adopt conclusions on promoting **youth entrepreneurship** to foster social inclusion of young people (<u>8378/14</u>). In this context, ministers will also discuss, in public deliberation, how to foster **an entrepreneurial mindset** among today's young generation, on the basis of questions prepared by the Presidency (<u>9012/14</u>).

Meeting of the <u>Education</u>, <u>Youth</u>, Culture and Sport Council - Justus Lipsius building, Brussels (starting at <u>10.00</u> with <u>education items</u>). <u>At lunchtime</u> an informal meeting between representatives of European youth organisations, ministers from the expanded troika (LT, EL, IT, LV) and the Commissioner for Youth, Androula Vassiliou, will take place. The <u>Youth session</u> will begin at 15.00. The presidency will hold a press briefing in the Council press room on <u>Monday 19 May at 14.00</u>. A press conference will take place at the end of the meeting.

Wednesday 21 May 2014

Education, Youth, Culture and Sport Council - Culture, audiovisual and sport issues

At its culture and audiovisual session, the Council is expected to adopt a recommendation for a decision designating Leeuwarden (Netherlands) as **European Capital of Culture for the year 2018** (9252/14). In this context, the Council will also adopt an implementing decision on the arrangements for the **appointment by the Council of three members of the selection and monitoring panel** for the European Capitals of Culture action (2020-2033) (9128/14).

The Council is also due to adopt conclusions on **cultural heritage** as a **strategic resource for** a **sustainable Europe**, calling in particular for more resources to be invested in cultural heritage as a part of sustainable regional strategies developed both at national and European level. The funding and development of digital cultural and creative content should also be promoted, including via Europeana (http://www.europeana.eu/).

Ministers will also discuss, in public deliberation, the topic "Addressing cultural policy challenges in the context of the next Council Work Plan for Culture", seeking to provide high-level guidance regarding priorities for the next Work Plan to be established under the Italian Presidency.

Finally, ministers will have an exchange of views on the **Transatlantic Trade and Investment Partnership**, on the basis of information from the Commission.

In its sport session, the Council will adopt a resolution on the **EU Work Plan for Sport (2014-2017)** (9131/14).

The Council is due to adopt conclusions on **gender equality in sport**, inviting member states and sport organizations to develop policies and programmes for eliminating gender stereotypes and to fight against gender-based violence in sport.

Ministers will also discuss, in public deliberation, the economic, social and environmental sustainability of major sport events (8751/14).
