PROMULGATING THE ACT ON AMENDMENTS TO THE MANDATORY HEALTH INSURANCE ACT

ACT

ON AMENDMENTS TO THE MANDATORY HEALTH INSURANCE ACT

Article 1

In the Mandatory Health Insurance Act (Official Gazette 80/13), in Article 3, paragraph 2, the words »Regulation EU No 1124/2012« are replaced by the words »Regulation EU No 1224/2012«.

Article 2

In Article 7, paragraph 1, items 14 and 15, the words »but not after reaching the age of 26 years« are replaced by the words »and for a total maximum period of eight years on this basis, if they do not exercise the right to mandatory health insurance on another basis«.

Article 3

In Article 40, items 1 and 2, the words »sick leave« are replaced by the words »temporary incapacity«.

Article 4

In Article 48, paragraph 2, the words »sick leave« are replaced by the words »temporary incapacity«.

Article 5

In Article 52, paragraph 1, a Croatian word translated as »items« is replaced by another Croatian word, with no relevance to the English translation.

Article 6

In Article 53, paragraph 1, item 4, the words »sick leave« are replaced by the words »temporary incapacity«.

Article 7

In Article 153, item 1, the words »sick leave« are replaced by the words »temporary incapacity«.

Article 8

In Article 154, paragraph 1, after the words »Article 46, paragraphs 2 and 9« a comma is inserted and the words »Article 78« are added.

In paragraph 2, the words »and Article 78« are deleted.

Article 9

Full-time students who, on the date of entry into force of this Act, had the status of the insured under mandatory health insurance due to the full-time student status, shall, from the date of entry into force of this Act, use this right in accordance with its provisions.

Article 10

Full-time students who reached the age of 26 years before the date of entry into force of this Act may acquire the right to mandatory health insurance in accordance with the provisions of this Act, provided that the period of their using the insured status on the basis of being a full-time student has not exceeded the maximum period specified in Article 2 of this Act.

Article 11

This Act shall enter into force on the first day after the day of its publication in the Official Gazette.
