Distinguished Guests,

In accordance with the Bucharest Action Plan for Cooperation between China and Central and Eastern European Countries adopted in December 2014 by Prime Ministers of these countries, I take the liberty of sending you information about the China Investment Forum 2015 (CIF 2015) titled “New Silk Road of the 21<sup>st</sup> Century – One Belt, One Road” Initiative: Challenges and Opportunities. The event will take place on 9 – 11 November 2015.

CIF 2015 will be held in the state rooms of the Prague Castle under the auspices of Miloš Zeman, President of the Czech Republic, and Bohuslav Sobotka, Prime Minister of the Czech Republic.

The topics of CIF 2015 panel discussions are: 1. Financial Cooperation, 2. Science, Technology and Research Cooperation, 3. Economic Cooperation, Trade and Investments, and 4. Tourism Industry Cooperation.

The CIF 2015 organisers are the Czech China Chamber of Collaboration and China Economic Cooperation Center of Communist Party of China.

Important political, social, and business representatives of the Czech Republic, People’s Republic of China, and Central and Eastern European Countries are invited to attend the Forum and engage in the discussions.

The People’s Republic of China will be represented by a CPC top-level leadership delegation, accompanied by more than 250 businessmen. Prominent representatives of several large companies ranking in high positions on the FORBES list have already confirmed their participation: ICBC, China Construction Bank, Bank of China, Alibaba, CEFC or Hainan Airlines Group.

We are also very happy to welcome prominent representatives of Beijing, Shanghai, Jiangsu Province, Hebei Province, and Zhejiang Province.

The organisers shall provide accommodation in the official CIF 2015 hotels, catering on CIF 2015 events and transport between the official CIF 2015 hotels and venues for the official guests free of charge.
